## GUEST FEE FOR ALL NON-RESIDENTS

Out-of-town guests must be registered at least 24 hours ahead of the time you plan to use the club; otherwise there will be a guest fee of \$3.00 for that day for everyone five years and older. In addition, please be informed out-of-town guests are not allowed to enter the facilities, unless a guest pass has been issued or with the homeowner. House guests must present out-of-town identification. Charge for local guests is \$3.00 for everyone five years and older.

## ATTENTION TO ALL RESIDENTS

## EXCERPTS FROM THE BOARD MEETING OF JUNE 2, 2011

**Homeowner Forum:** Mr. Brana presented the Board with a letter requesting the Winston Park Homeowners Association join the Horse Country Homeowners Association in their efforts to stop Archimedean Properties LLC from expanding their schools attendance from 800 students to 1300 students and its hours of operation. This increase will ultimately increase the already heavily driven Sunset Drive. After a brief discussion the Board did not agree with Mr. Brana's request.

**Snack Bar:** The property manager informed the Board that the snack bar will be opening on Friday, June 10 and requested \$750.00 to cover start up costs. It was motioned to approve spending up to \$750.00 for costs to open the snack bar. Motion passed unanimously.

**Office Telephone System:** Management informed the Board that the current phone system parts is discontinued and a new system needs to be obtained. Proposals were obtained from Advance Mirco Service of \$1,399.65 and one from AT&T for \$1,750.00. It was motioned to spend up to \$1,399.65 for the purchase of the new phone system. Motion passed.

**Annual Staff Increases:** Management reviewed the current staffs' positions, length of service and their current salaries. After much discussion, it was motioned to increase all staff members by 50 cents an hour. Motion passed unanimously.

**Roof:** The president of the Board informed the Board members of his discussion with the Association's attorney Ms. Sasha Sampairo. Ms. Sampairo suggests that the Association stay out of Murton Industries lawsuit and the Association sue the three (3) remaining companies. Mediation to take place, scheduled date to be announced.

## NEW HOMEOWNERS AND RENTERS

**Homeowners:** If you are a new homeowner it is necessary for you to bring in your Warranty Deed or closing papers. Only the Deed or closing papers are acceptable.

**Renters:** Please bring in your leases or updated ones if you have been a renter for a long time. Please be informed that unless we have your new leases or updated ones, you will not be permitted to enter the clubhouse.

TO ENTER THE CLUBHOUSE FACILITIES YOU WILL NEED YOUR NEW LEASES OR UPDATED ONES. IF EXPIRED, YOU WILL NOT BE ALLOWED TO ENTER. It is imperative to have our files updated for your convenience and ours.

## CODE ENFORCEMENT-GARAGE SALE SIGNS TEAM-METRO

Special notice: Illegally placed "GARAGE SALE" Signs are being ticketed. Code Enforcement is cracking down on signs which are placed on median strips and other places on the "right of way". ONLY TWO garage sales are allowed per year, per homeowner. Signs must be removed immediately after the sale, before the next day, or fines will be levied.


## SNACK BAR HOURS

# Lightning Is A Serious Danger!




## How To Stay Safe

Florida is the lightning capital of the United States. More people die or are injured by lightning in our state than anywhere else. We urge you and your family to take extra care during thunder storms

If you hear thunder, you are within striking distance. The National Weather Service recommends the following: the 30-30 rule. When you see lightning count the time until you hear thunder. If that time is 30 seconds or less, the thunderstorm is within 6 miles of you and is dangerous. Seek shelter immediately. The threat of lightning continues for a much longer period than most people realize. Wait at least 30 minutes after the last clap of thunder before leaving the shelter. Don't be fooled by sunshine or blue sky!
